The *Growing Opportunities* (GO) Driver Program is a one month training program that prepares City residents for a career as a Transit Bus Operator with Charlottesville Area Transit (CAT). The program, entirely free for eligible participants, is a partnership among the City's Office of Economic Development, CAT, and Piedmont Virginia Community College to offer one full month of training that will equip residents with a National Retail Federation Customer Service Certificate, Career Readiness Certificate, and workplace essential skills. After successful completion of this program, participants will have the opportunity to be considered for employment with CAT as a relief Transit Bus Operator. Once hired, participants will receive an additional one month of training with CAT to earn a Commercial Driver's License (CDL).

RELIEF TRANSIT BUS OPERATOR JOB DESCRIPTION


CAT provides scheduled, fixed-route public transportation. CAT's goals are to provide dependable, efficient, convenient and safe transportation alternatives to the private automobile for the citizens and visitors of the Charlottesville area. The Transit Bus Operator performs semi-skilled work in the operation of large passenger buses. Relief drivers work as needed to maintain full service for the public. Flexibility is available in scheduling, with a minimum of 20 hours per week guaranteed. Pay starts at \$14.88 an hour.

GO DRIVER TRAINING PROGRAM INFORMATION

Anticipated GO Driver class times will be 5 hours per day, Monday through Thursday, for a total of approximately 90 hours of class time. Preemployment training will begin in late September or early October and will last one month. The tentative schedule includes the following:

- 40 hours of training for the National Retail Federation Certificate in Customer Service and High Level Soft Skills
- 16 hours of training for the Career Readiness Certificate
- 16 hours of training on Workplace Essential Skills
- 8 hours of training for the Commercial Driver's License (CDL) Learners Permit Test Preparation (participants will take and receive their Learners CDL prior to employment with CAT)
- 8 hours of training on Charlottesville routes and geography
- 2 hours of Job Coaching
- 1 hour per week of Mentoring

CAT Requirements

- ___ I have a GED or High School Diploma.
- ___ I am willing to submit to initial drug screening.
- I have a driving record with -4 points or better.
- ___ I have not been convicted of any barrier crimes that would prohibit me from getting hired by CAT as a relief bus driver.

DMV Requirements

- I do not have any CDL disqualifications.
- ___ I have not had any DUI convictions within the last 7 years.
- I am able to meet the required Medical Examiner's criteria. (no use of Schedule 1 drugs; vision in both eyes 20/40 with visual improvement devices; ability to distinguish color; blood pressure lower than 160/100; cannot have diabetes that requires insulin injections; maximum level of blood sugar is 200)
